

THE HISTORY BEHIND THE CROSSING THE LINE CEREMONY

According to Greek Mythology, the original God of the Seas was a certain diety called Poseidon. During his reign, Greek sailors were accustumed to burning incense and singing such appropriate odes as "Eternal Father" to intercede for his good offices and therefore bring on smoth sailing.

Poseidon's wife, Amphitrite, was the daughter of Oceanus, a very powerful Greek God in his own right.

When the Romans ousted the Greeks and became the primary power in the area, they installed Neptunus as their ruler of the Seas. Adding insult to injury, Neptunus adopted Amphitrite, thus becoming Poseidon's father-in-law. Poseidon was so depressed by this event that he committed suicide by drowning himself in his ocean leaving Neptunus as <u>King of all the Seas</u> with the right to extoll fees or homage from all who enter his domain.

The origins of the ceremony have been difficult to trace.

One source of information claims that during the 17th century

when entering the Straits of Gibraltar, all those who were

entering for the first time had to pay their fee or else be dunked

from the yardarm. The enactment of this ceremony was transferred

to the Tropics, and eventually, to the Equator. Why the Equator

was the final choice and not the International Date Line or the

Arctic Circle is anyone's guess.

Another source of information has it that the ceremony was initiated in the Royal Navy's East Indian Fleet during the tenure of Admiral Horatio Nelson. Since most of our more peculiar customs seem to be dear old Horatio's fault, this source may very well be true.

The ceremony is mentioned in an old B.R. called "Sports and Recreation in the Royal Navy." The authors admit that it originated from some form of "pagan religious rite".

A lengthly description is given of the ceremony held by the crew of H.M.S. NEW ZEALAND when she crossed the Equator in 1919 with Viscount Jellicoe aboard. This was a revival of a ceremony which had obviously been abandoned. We are, however, indebted to them for their contribution to the handbook which points out "it is hoped that the ceremony and text may prove helpful to future generations of those who occupy their business in great waters"

When comparing the two ceremonies mentioned in the B.R., we notice that although the general pattern is unchanged, the text is altogether dirrerent. This illustrates how the script must be adapted to the local scene: that is, the Captain may or may not be a SHELLBACK, and all charges made against the defaulters must be original.

There has always been a great reluctance on the part of the TADPOLES to being initiated -- and their fears are well founded. -- however, it must be realized that this ceremony should be

taken in fun, otherwise the whole spirit will die.

NOTE: SHELLBACK - one who has been initiated in the Realm (the good guys)

TADPOLE - uninitiated, UNCLEAN.

The following pages contain the script for the "Crossing the Line" ceremony as enacted by the "PROVIDER PLAYERS" on the occasion of their passage from Esquimalt, B.C., to Suva, Fiji, at Longitude 166'W, Latitude 000, on the th day of Febuary 1978.

The ceremony is broken down into three phases:

The first phase begins the previous night when the Herald of His Oceanic Majesty comes aboard in order to inspect H.M.C.S. PROVIDER and decide upon her worthiness to receive onboard NEPTUNUS REX, in all his glory.

The second phase begins when NEPTUNE, after receiving a favourable report from his Herald, arrives on board the following day, accompannied by all of his court. His first act is to present Orders and Awards to Trusty Shellbacks, and to see any defaulters that have incurred his wrath.

The third and final phase takes place when KING NEPTUNE supervises the initiation of the TADPOLES...

The following dialogue is heard over the ships

Broadcast.

BRIDGE - Capt - 00W Sir have contact on radar bearing red 45° range 2000 yds.

CAPT - Capt - very well plot

LOOKOUT - Lookout - OOW Sir that contact at red 45° is closing

CAPT - Very good. That will probably be King Neptune's Herald. Alter course towards.

BOSN MATE - Make a Pipe. Clear lower decks to the forecastle.

Guard to muster on the forecastle.

The ship alters towards the alleged contact and nothing further is heard until Ship's Company is assembled on the forecastle. Both Captain and Herald speak through loud hailers. (The Herald on the forecastle, Captain on the bridge)

HERALD - (from behind spray) Ship Ahoy

CAPT - PROVIDER

HERALD - I am the Herald of the Court of His Oceanic Majesty,
King Neptune. I heard your ship was around, now
tell me whither bound.

CAPT - From Hawaii shores to the Fiji Isles. Altering course every 30 miles. Now I've lot to de, tell me stranger who are you?

HERALD - (Steping through the spray waving his sword menacingly) I am no stranger and uphold the right to board your ship this very night. As Neptunes Herald, I mean to find out if this ship is clean.

CAPTAIN - You'll find it clean, I have no doubt. We are Ship

Shape in and out and now ithout further ado inspect

the Guard I've mustered for you.

HERALD - Very well Captain. I'll do your will, faithfull

Bugler, sound the still - Blow it hard - Davey Jones

Inspect the Guard.

(Davey Jones, with a cortege of a Bugler and 4
Bears, advances through the spray. Bugler sounds every
off key alert. Davey Jones receives the report of the
Guard Officer and then proceeds with the inspection,
using lots of slapstick with a dead fish, i.e...
haircut, shoes, etc....

DAVEY - So this is the Guard you mustered for me. A more horrible sight I've ever did see, I've inspected many, and I can tell they look unclean and smell like Hell.

BEARS - Shriek "UNCLEAN" "UNCLEAN" Bears growl and shout

I was the spy who scanned the papers to learn what
I could of numerous capers that have been pulled by
this ships crew, now listen closely while I tell you
from this unclean and notely mess one hundred ninety
persons more of less will learn tomorrow of this
horrible fate from the Royal Court of Neptune the
Great and furthermore, I must report I'll plead no
mercy from this Court.

THE BEARS ONCE MORE SHRIEK "UNCLEAN" "UNCLEAN".

HERALD - At four bells of the forenoon watch to-morrow come
what may - his Oceanic Majesty King Neptune will
sway and by the ancient laws laid down by custom will
ordain - that all you Tadpoles young and old be
initiated in our name.

SCRIBE - All hail - King Neptune.

(the Bears in a fit of fanatic fervous shriek)

"BLOOD" ""BLOOD""

CAPTAIN - Keep silence

We shall be ready for your King and glad to meet his Queen now, will she bring her Daughters fair to beautify the scene. (Bears emit HOWLS and WOLF calls)

HERALD - It cannot be a seanymphs form would take each
sailors heart by storm. Our good Queen spares them from
such woes because they haven't any clothes.

MORE WOLF CALLS FROM THE BEARS

(The company starts retiring through the spray, the
Herald goes last and pauses to say in a loud voice.

HERALD - I recommend you all rest with sorrow - the fittest only will survive to-morrow.

Fx. lights are turned out, and a hinenous, sub human laugh is heard from the eyes of the ship.

Many lights of various colours are shot off from Fx.

The scene shifts to the cargo deck the following morning

Lower Decks have been cleared to the Cargo Deck. King Neptunes Court in full regalia has assembled in the R.A.S. stores and flats. The Bears and Police have placed themselves around the Royal Throne awaiting the grant entrance. The Herald comes to the

HERALD - "Hear ye, Hear ye. Make way for his Glorious Majesty

Neptunus Rex, Rules of all who sail upon the sea.

Hear ye, Hear ye.

Cargo Deck.

- King Neptune enters - followed by the Queen, Mermaids and the remainder of the Royal Court.

HERALD - "All Hail King Neptune"

The Bears and Pelice repeat "All Hail King Neptune",

The Police make sure there is room for the King and

Court to be seated. After all have taken their positions on the thrones, the Captain steps forward to address King Neptune.

CAPTAIN - "As Captain of this Ship
In humblest duty, sire I bring
to you our Oceanic King
All here on Board. May we submit to
what in ancient Laws is writ".

NEPTUNE - Good Morning Provider, you've come a long way, and
I've waited months for this glorious day. You all Know
full well what I've come to do. For I hear there are
Tadpoles among your crew. My barbers are good and widely
renowned, (the barbers step forward and wave tools of
their trade).

Their razors are sharper than have ever been ground.

My doctors are butchers and as for their pills, they're better than Ex-lax for curing your ills.

CAPTAIN - "Before you punish our crimes with that terrible fork, I present for your favour, my crew to your court.

NEPTUNE - "Sir I am honoured to meet you and my Bears in salt water will handsomely greet you. Since you first crossed our line was it 64?

Your rank is greater so is your weight, your loyalty and trust is something great, a loyal Shellback we appreciate, you move around on many a ship, a racing quinchy you never tip, as a veteran member of a ships crew.

Honourary Police Chief's rank, is awarded to you.

(Captain kneels, pause while star is awarded)

I give you this star, so after you cross the Ships

Company will know Keith is the boss.

HERALD - "Awarded the rank of temporary acting honourary Chief
of Police second class"

Carry on.

The Captain rises and moves to the background as Neptunes address the crowd.

NEPTUNE - "From my courtly Herald I've been told that some in your crew so brave and bold as to warrant my favour there may be some missed, so Herald bring forward my Honour list. The Herald calls out the names as follows:

CDR STEELE

HERALD - "As Executive Officer and number one wheel, before our great KING we must ask you to kneel.

NEPTUNE - While you kneel before me illustrious X.O., we have here an honour on you to bestow. Although a short-timer, it's quite plain to see soon 19 years of service will it be. You're old fashion ways and kipper accent are in tune with the times so do not repent, for service so loyal, we bestow this award directly from Gieves, this small golden sword.

NEPTUNE THEN SAYS

NO wrong you have done, but a promise we ask, its really quite simple and hardly a task, an extra beer all around is easily done, to round this day of mischief and fun.

What say you??

X.O. "It shall be done."

HERALD - Arise Sir Knight Commander of the golden sword.

Double smart yaway and organize the beer.

Lt McFADYEN

HERALD - Kneel.

Smiley McFadyen is our head cargo man

He tries to be obliging as he possibly can,

He tries to be helpful to our friends in Athabee

But ships run on oil, not water from the sea.

Awarded the Order of the Fuel Sampler.

HERALD - Rise LCO with the smile on your face

If you give all the water to east coasters

We'll be down to trace.

HERALD - If your majesty finds it convenient, we had

time enough to be lenient. It's just about time

for that tank of brine, to make some new shellbacks

"Crossing the line", and if you will see defaulters

first, we'll save till last the best... and worst.

NEPTUNE SAYS "So be it"

- HERALD "Hear ye Hear ye Hear ye -" The local shellback cours of His Oceanic Majesty Neptunis Rex is now in session "Judge Samual J. Seaweed presiding."

 The defaulters are held in any order.

- HERALD For many years he's bided his time, and sailed up north avoiding our line, This is no crime as you can see, but to terrorize young lads is a felony. So here in this court, the Judge will agree, he's tried fair and square and is guilty. So take him oh bears and of this I trust, dunking 4 or 5 times is a definite must.

JUDGE - "Guilty of terrorizing grimeys - dunk him."
P2 STEWART

HERALD - "While scanning the books, your Honour I find,
a crime's been committed of a different kind. He
handles the money and juggles the books, but has
his excuses like most other crooks. His reasons and
excuses though somewhat absurd, about changing money
he speaks not a word. And this your Honour strikes
me funny, he certainly should change Ship's Company money."

JUDGE - "This crime though it's small, like you hear of in school, I'll let you off lightly because you're no fool.

Can't just dismiss it, I'll go by the rule, dunk him you bears, 4 times in the pool. Take him away".

AB MARINELLI OS MORRIS (Brought forward by police)

HERALD - "Here stand two Bos'n tadpoles small and short,

About to face King Neptune's ourt. It has been observed by one and all that in the heads they're not too tall.

The bowls are past their ruddy knee -- so sqat they must, therefore, to pee. Before we kear their moans and lament, I offer them to the Court, for punishment."

JUDGE - "You are small and you are short, but remember as

Judge of the Court, with the charge I must agree,

you're just not allowed to squat to pee. Guilty as

sharged, you tadpole scrubs, I order you into the

Royal Tub."

MWO MITCHELL

HERALD - "Since you're not the one who sweats and cooks,

And stands abuse and ugly looks.

Trying to keep things hot for noon,

We feel you are entitled to the greasy spoon."

JUDGE - "I could not agree anymore,

Dunk him at least 2 or 4."

LS BENNETT LS DAVIS

HERALD - Two tadpoles before you with growth on their face,

I think this your Honour, is a terrible disgrace.

The Royal Doctors and Barbers, without being mean,

Should cleanse them and shave them and declare them

clean, when they become shellbacks, -- but not until

then, their whiskers and haircuts can start once again.

JUDGE - Barbers and Doctors I'll give them to you, to cleanse them and dunk them in front of the crew, to make them true shellbacks, you bears I do trust, to dunk 4 times is a definite must. AWC JOHNSON

HERALD - Before you King Neptune we have to impune AWC JOHNSON, a definite loon. His mates and his bunkies are all aghast, that he'd bring to your realm 10 tons of gash.

NEPTUNE - The 16 ton of gash has been plain to see, This tool brought everything, but a colour TV.

JUDGE I give you now my Royal Decree, Into the tank 2 times, NO make it three. Lt BROWN

HERALD - HARK.. purveyors of the half-dead germ Tadpole it is now time for you to squirm. Needles, pill, enemas and such We can take just so much.. (Doc Brown and his nurse BIRDIE led forward in chains)

JUDGE - With needles bent and tips so dull, you have done the jabbing, But now the tables are turned and we'll do the stabbing. So be prepared to suffer more, into the tank with 3 or more.

Lt McFADYEN

HERALD - For special charges ... The LCO is the boss of the few Who Davey Jones thinks is the cream of the crew, For all their days off he's put in the bank Shipwrights agree 4 dunks in the tank.

JUDGE - Guilty of banking with no interest, you all,
Four deposits into the tank for withdrawal.

OSCAR

HERALD - For many years he's bided his time

Sailing the oceans north, avoiding the line.

But like a sailor and many a mate

Has known before this court to learn his fate.

During work-ups on the briny main

All we've heard is "Man overboard" "OSCAR's at it again".

You've done a deed which leaves us cold

How a tad like you could be so bold

It's now quite clear we know your aim, twas to give this ship a horrowing pain.

JUDGE - Dunk him two times and more. What the Hell, make it four,

CONCLUSION

When all or nearly all, tadpoles have been initiated, the Herald calls for attention for King Neptune's farewell:-

HERALD - "Hear ye - Hear ye - silence for his Oceanic Majesty,
King Neptune."

NEPTUNE - "King Neptune, I, Lord of the Brine, welcome you all,
new subjects of mine. I am the Lord of the Oceans wide.

Lord of the Rivers, Lord of the Time. My laws are strict
but do not fear, if you will only persevere, to keep the
freedom of the seas, as recognized by our decrees. Here are
the bears, the suds, the bath, they are the only certain
path, for all who wish to cross the line, and be
enrolled as sons of mine. I command you go now, your many
ways, take what you have learned to future days. Teach

others the mysteries of my mighty deep, I go now, below, my vigil to keep.
