Don was an excellent engineer both reliable and efficient. He has been with me for a long time now and we had become more friends than officer and rating. He was always making things for all the lads and was very well liked by both officers and men.

The only minor comfort I can give you is that he was down below at the time the ship was hit and as the ship sank instantly I am sure he did not suffer any pain.

I hope that if I am ever in Nanaimo you will gite me the pleasure of allowing me to call on you.

If there is any way in which I can help you, do not hesitate to write me.

Dear Mrs. Grais:-Further to my letter of the 23rd August, details of the disaster in which your husband has been reported missing are now being released. H.M.C.S. "ALBERNI" was sunk while on invasion duties in the English Channel. Four officers and fifty-five ratings are missing, with three officers and twenty-eight ratings having survived. It is regretted that the position of the loss cannot be given, but it is considered unlikely that prisoners of war will be taken. It is requested that you will keep this information in confidence until an official announcement is made. May I again express sincere sympathy with you in your anxiety. Yours sincerely P.A. Further to my letter of the 28th of August, 1944, I regret to inform you that in view of the length of time which has elapsed since your husband, Donald Borden Grais, Engine Room Artificer Third Class, Official Number V-30724, Royal Canadian Naval Volunteer Reserve, was reported missing from H.M.C.S. "ALBERNI", and as no news has since been received to the contrary, the Canadian Naval Authorities have now presumed his death to have occurred on the 21st of August, 1944.

Please allow me to express sincere sympathy with you in your bereavement on behalf of the Minister of National Defence for Naval Services, the Chief of the Naval Staff, and the Officers and men of the Royal Canadian Navy, the high traditions of which your husband has helped to maintain.
