

I am directed to advise you that you are now under consideration for entry into the Royal Canadian Navy as an Acting Engine Room Artificer, 4th Class, under a Seven Years' Continuous and General Service Engagement.

Before your entry can be approved it will be necessary for you to undergo final medical examination and Trade Test. You are to report to the Commander, R.C.N. Barracks, Esquimelt, B.C., at Nine A.M., as soon as possible, showing him this letter as your authority, when he will arrange for your medical exemination. You should hand the Exemining Medical Officer the enclosed Forms B207 in triplicate (Medical Examination Form) and B207A (Physical Qualifications Required).

Transportation Warrant No. 16672, Ganges, B.C. to Victoria, B.C., is enclosed, which you should exchange at your local Canadian Pacific Steamship Ticket Office for a steamship ticket.

Provided you are found physically fit and suitable in all other respects, you will be entered in the Royal Canadian Navy as an Adting Engine Room Artificer, 4th Class, forthwith.

If you are not physically fit, the Commander, R.C.N. Barracks, Requimelt, B.C., will so advise you and supply you with the following transportation back to your home: -
