





It is with deepest regret that I must confirm the telegram of the 5th of May, 1945, from the Minister of National Defence for Naval Services, informing you that your son, Douglas Lawrence Rogers, Petty Officer, Official Number 4205, Royal Canadian Navy, has passed away on the 3rd of May, 1945, under the anaesthetic during an emergency appendectomy at sea.

He was buried at sea with full naval honours at one o'clock in the afternoon of the 4th of May, 1945.

No other information was received at this time but as soon as further particulars are available they will be passed on to you immediately.

Please allow me to express sincere sympathy with you in your bereavement on behalf of the Minister of National Defence for Naval Services, the Chief of the Naval Staff, and the Officers and men of the Royal Canadian Navy.
